




## MEMBERSHIP




## CONSTITUTIONAL IMPLEMENTATION

- Advisory Board






## CONSTITUTIONAL AMENDMENTS 31.5.2020

At the earlier stage of the constitutional implementation, few issues came to bear that shows that an amendment will be needed.

A committee was set up to review the constitution. The recommendation was tabled before the board. Congress was called to vote on the recommended changes and eventually a new version 2 of the constitution was release on 31.5.2020.



## INAUGURATION OF ASANTEMAN EUROPE

When we took office in 2018, the association has not been inaugurated yet. We immediately opened application for member union to apply.

In the end Asanteman Traditional council was the only applicant and after fulfilling the requirement was awarded the hosting right. The event was to take place in 2019 but due to covid-19 travel restrictions, we have to postpone until 2nd July 2022 when we finally inaugurated the association in Amsterdam. In the heat of COVID-19, the executive council instituted a committee (Nana Afia Achiaa Deiwaa I, Mr. Ernest Appiah and Nana Amma Konadu) to raise funds. The committee lead by Nana Deiwaa, raised EUR 23,243. The same committee were tasked to lead the donation. Asanteman Europe donated some hospital equipment and COVID-19 preventive items to four (4) health institutions in Ghana to bolster their activities and improve healthcare delivery in the country.

The items worth EUR 23,243 equivalent to GHC 196,403 included 10 beds and their accessories, and two phototherapy machines to the Manhyia Hospital; medical overalls, surgical nose masks, gloves, face shields, and cartons of customised bottled water to KATH, the Kumasi Centre for Collaborative Research (KCCR) and the Noguchi Memorial Institute for Medical Research in Accra. Part of the money was also used in providing food to 8 communities with the Ashanti region. Read more in the committee report

Asanteman Europe made a cash donation of €500 back in 2019 as a support towards the foundations work.




## ASANTEMAN EUROPE WEBSITE

## INAUGURATION PROJECT-ONGOING

During the inauguration, a fundraising was done towards the theme of the inauguration "Empowering the Ghanaian child through Education: the role of Asanteman Europe"

A cash amount of €4,773.83 was raised and a pledge of €2,800 In addition, we had 100 laptops with educational programmes installed and 10 pcs of sewing machines.

The cash amount, 100 laptops and 10pcs of sewing machines have not been donated yet and

we expect the next administration to take this project forward.

2018 Balance: €2,136.78

As of 31.12.2018, the association account balance was €2,136.78

2022 Balance: €15'749.28

As of 2.12.2022, our account balance is €15'749.28. The amount is inclusive of the inauguration project donations(€4,773.83)



## CHALLENGES

Even though we have been able to set up a solid foundation for the association, nevertheless there have been challenges that prevented us from doing more.

- COVID-19 was obviously one of challenges as it prevented us from caring out most of our plans.
- Chieftaincy issues-There were a lot issues for us as executives to resolve and these issues were becoming a distraction.
- Our team chemistry wasn't good and that also affected us
- Getting the participation of individuals in Asanteman Europe media activities was not easy.

## RECOMMENDATION

- Videos and photography should be taken seriously when conducting major events in the name of the association.
- Membership mobilisation should be top priority going forward
- We recommend to engage the existing members and organise interesting event that will encourage their interest.
- The executive council should stand as one and have one voice at all times (Unity), as well as respecting each other.
- The board should also ensure and encourage the executive council to stand as one
- The new administration should make sure there is a smooth working relationship between them and the house of chiefs by making sure each body or organ is working per the responsibilities as in the constitution.
- Executives should ensure members are following the rules and regulations on the general whatsapp platform. Members should be responsible on the platform.



## CONSTITUTIONAL RECOMMENDATION

- On the Life Patron of Asanteman Europe-Executive council propose we change the name from Personality to Office (Asantehene) to be more generic such that any Asantehene will be the Life Patron of Asanteman Europe
- The Executive Council Term of Office-Proposal is to change from 4 years to 2 years.
- **Disciplinary and Arbitration Committee** Executives propose that all issues that will happen within Asanteman Europe must be directed to the committee.
- Number of Executive Council members should be trimmed from 11-7.
   Executive council propose that the following positions should either be dropped or combined
  - Drop 2nd Vice President
  - Drop Financial Secretary position -Duties to be administer by Treasurer
  - Drop Deputy Organiser.
  - Combine Media and Communication and name it as Head of Media and Communication. The head of media will have his or her team to work with and this will smoothing the work of this department.
- Board Members: Reduce the representatives to one per member union and also reduce the number of executives at the board. Preferrably President and Secretary should be the only once at the board.





## CONCLUSION

There is the need to do more for the growth and development of the Association. We appeal to you all to help the association in whatever way that you can.

The leadership of the association should put together an action plan and recruit people to be in charge of some structures and activities in order to build a strong association.

There is also the need for members to feel the benefits of the association more than ever before. Anyone who takes up a position or role in the association should remember to do so SELFLESSLY and be ready to work as best as he or she can with all others for the good of the Association.
